<u>Cancellation of Exhibit Space</u> The OVFA may cancel an exhibitor for breach of any rules or regulation as spelled out in this document. If an exhibitor is cancelled for cause resulting from negligence or non-compliance with this document, OVFA reserves the right to retain all or any portion of the exhibit fee.
