

How to complete this form

- 1. Do not alter either side of this form in any way. Alteration of the form will result in disqualification of the petition, and signatures on it will not count towards the required 10,000 signatures.
- You can make as many copies of this form as you wish. (Helpful idea: fill in the name of your organization at the top of the petition prior to making copies.)
- 3. Do not add names to a blank piece of paper or on the back of this form. They will not be counted.
- 4. Do not add additional lines to the petition.
- 5. Each line item must be completed for qualification (e.g., signature, date, print name, residence address, city and ZIP code, and county of residence.
- 6. Everyone who signs this petition must be a registered voter in the state of Oregon.
- 7. The petition circulator must be of voting age, but does not have to be a registered voter.

- 8. The petition circulator must be present and see each person sign the petition.
- 9. The petition circulator must sign and print his or her name at the bottom of the petition.
- 10. There are no restrictions on gathering signatures from differing geographic locations. Therefore, you are not required to submit separate eligibility petitions for each county in which signatures are gathered, or in which registered voters are living.

Remember...

If a registered voter neglects to complete any box, that line will be subject to disqualification.

If the organization's name is not clearly addressed at the top of the petition, the entire petition is subject to rejection.

If the circulator does not sign and print his or her name at the bottom of the petition, the entire petition is subject to rejection.
